Report on Activity Organized by Invertis University in January 2023

Title: Creating Awareness for the Internal Complaint Committee (ICC)

Date: 03 August 2022

A Q&A session followed the presentation, allowing students to clarify doubts and gain clarity on the complaint filing process.

The participation and engagement levels were commendable across all segments of the university community. The campaign led to increased awareness about the ICC, its significance, and the ease of filing complaints.
